The animals that are cared for by the Mohawk and Hudson River Humane Society are lucky they live in a community that supports their local animal center in so many different ways.

**Volunteers** give generously of their time to train dogs, clean kennels, care for cats, sort bottles, help with administrative efforts, serve on committees and our Board of Directors, provide dozens of foster homes each year, help manage our two satellite adoption centers, assist with events, and educate the community about the needs of animals.

**Individual Donors** give generously over the year – it may be a one-time gift, or several smaller gifts. Each and every donation received by the Society goes directly to help care for the thousands of pets that pass through our Animal Care Center in Menands each year.

# **A COLLAR CITY RESCUE**



Taffy – a beautiful, young white cat was brought to the Society's Animal Care Center with two kittens and a large wound all the way around her neck. Our medical team thought a string had been tied too tightly around her and had slowly embedded itself into her flesh. The hungry stray from the streets of Troy was overjoyed to finally be receiving human attention while being examined. She kept rolling onto her back and rubbing her face against anyone giving her any affection. Our medical staff anesthetized her so that her wound could be examined, cleaned and treated. They soon found that someone had put a rubber band around her neck some time ago, and it was deeply embedded. About 60% of the circumference of the wound had healed and scarred over. That scarring was a process that took several weeks while Taffy quietly suffered and cared for her kittens.

The rubber band was two inches shorter than the circumference of Taffy's neck and could not possibly stretch enough to avoid injury. The band may have been placed on her either as a young kitten and her neck grew around it or carelessly placed on her a few months ago and never removed. No one checked to see why she was irritated, in pain or why she had open sores. No one cared enough to remove it, let alone have her seen by a veterinarian. She was just left to suffer with this painful and infected wound until she came to our Animal Care Center in Menands.

Fortunately, Taffy received the medical attention she needed and has made a full recovery. She may have a scar around her neck, but the injury that caused the pain will soon be a distant memory thanks to the excellent care she received. Taffy has recovered well under the watchful eyes of our animal care team while the Society's investigators worked on her case. Investigators are still looking for anyone who may have information about this cat who was found on Second Avenue in Trov. Taffy and her kittens have been adopted by loving and caring families, safe from the careless people who allowed her to suffer.

## **FROM THE DIRECTOR**



Today, a four-month-old puppy was brought to the Society with a severely broken leg. He was brought to us by the police because the owner had thrown this defenseless creature across the room after the puppy urinated on the floor. Unfortunately, cases of violence against animals like this one are all too common, but this one was different. According to police, the man who brutally attacked this puppy had assaulted his wife a year before.

For over a decade, researchers have been documenting the connection between domestic violence and animal cruelty. What they have discovered is as shocking as the experience of this puppy. This was by no means an isolated incident and

literally hundreds of similar situations happen every year around the country.

- Between 25% and 40% of battered women are unable to escape abusive situations because they worry about what will happen to their animals should they leave.
- 68% of battered women reported violence towards their animals. 87% of these incidents occurred in the presence of the women, and 75% in the presence of the children, to psychologically control and coerce them.
- 13% of intentional animal abuse cases involve domestic violence.
- Abusers kill, harm, or threaten children's pets to coerce them into sexual abuse or to force them to remain silent about abuse.
- Disturbed children kill or harm animals to emulate their parents' conduct, to prevent the abuser from killing the pet, or to take out their aggressions on another victim.

In light of the overwhelming statistics showing that animals *and* families are at risk, and the suffering that people *and* animals have endured, we at the Humane Society decided to take action.

The Mohawk and Hudson River Humane Society and Unity House have come together to create a new 'Safe Haven' in the Capital Region. When a woman enters Unity House's shelter, she can bring her pets with her and they will be housed at the Society's Animal Care Center or in one of our 80 foster homes. Once the animals are at the Society, we will provide any vaccinations or other medical care needed by the animals.

Now, children will no longer be exposed to abuse because there was nowhere for their pets to go. Women who have delayed leaving abusers because they were protecting their pets can now safely leave with their entire family – those with two legs and four.

There is no government funding for programs like this one. It is only because of the kindness and generosity of our donors that these animals are protected. Thank you to all of you who support the Society so we can provide these programs. Thanks to you, when a woman calls about an abuser threatening to harm her and her pets, now we can say "leave, and take them all with you."

October is Domestic Violence Awareness Month and the Society will be working with our partners to educate the community about the link between animal abuse and domestic violence.

- Join us on October 4th at Classy Lassie Fields in Wynantskill for Unity House's Domestic Violence Awareness Day.
- On October 7th we will be participating in a seminar Sponsored by the Department of Criminal Justice Services at the Schenectady YWCA to educate professionals and the public about the connection between domestic violence and animal abuse.

## **VOLUNTEER SPOTLIGHT** By Deidre Bruce, Volunteer Manager



Reed and Betty Parvis never expected their volunteer positions with Mohawk & Hudson River Humane Society to become what they are today.

"We decided we were going to walk dogs," explained Reed, a retired electrical engineer from Colonie. His wife Betty, an insurance professional, joined him in retirement in June 2006. They set out to volunteer with the dogs at the shelter in their spare time. They attended volunteer orientation, but dog-care training would not take place for several weeks. That's when they received a call from the development office asking if they could help with filing.

Reed and Betty began coming to the shelter nearly every day to file and perform other clerical work. They organized and perfected a process for large mailing projects, started helping at the cat adoption center in PetSmart in North Greenbush, and had finally attended Introduction to Dog Care when someone suggested they should research the history of the organization.

"We found a deed (to the Society's property in Menands) in the Albany County Hall of Records dated 1913," Reed said. According to Reed and Betty, the deed appeared to indicate more property owned by the Society than previously known. Excited by their findings, they were just getting started.

Reed and Betty attended a workshop on nonprofit law to learn more about searching for important historical documents on the Society. They were able to trace the history of the Society's land to the will of William Patterson Van Rensselaer, which they located in New York Surrogate Court in New York City. Van Rensselaer bequeathed the land in Menands to the Society in 1913. "We still haven't figured out the relationship between Van Rensselaer and Dr. William Stillman (one of the Society's founders)," added Betty. Their search for information about the Society would lead them to libraries, dusty books in the hall of records, and introductions to town and village historians.

Reed and Betty's research is far from complete but some of what they've learned has sparked another interest. "Trail clearing is something new for us," laughed Reed when he described how he and Betty have begun bushwhacking the nature trail on the Society's property where volunteers walk the dogs. They're determined to clear the path to a piece of land that their research has put on the Humane Society's map. Reed and Betty have three grown children, five grandchildren, two dogs, and a cat. They vacation in a fully equipped mobile home, and always take their pets with them. They are frequently seen helping out in their various roles at the Humane Society. They make themselves available for last minute requests, like the time they drove a dog to a rescue group in New Hampshire.

Co-bulk mail agents, cohistorians, PetSmart adoption assistants, dog transporters...Reed and Betty are happy to help wherever they are needed. And we are thankful to have the Parvises as part of the Mohawk and Hudson River Humane Society team.
